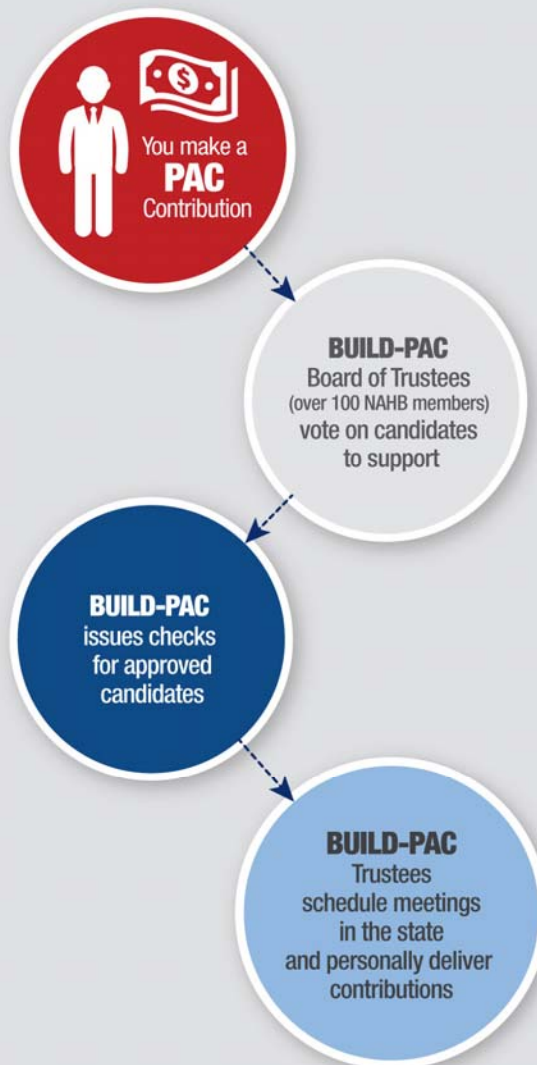

Contributions to BUILD-PAC are completely voluntary. You have the right to contribute without reprisal. Contributions to BUILD-PAC are designated for the calendar year in which received. BUILD-PAC may accept personal contributions up to \$5,000 per calendar year. You must be a U.S. citizen or a green card holder with permanent resident status to participate. Contributions by foreign nationals are not permitted. Contributions to BUILD-PAC will be used solely for political purposes. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and employer name of any individual whose contributions exceed \$200 in a calendar year. BUILD-PAC may only accept personal, non-corporate checks. Corporate contributions received will be used for other NAHB activities.
